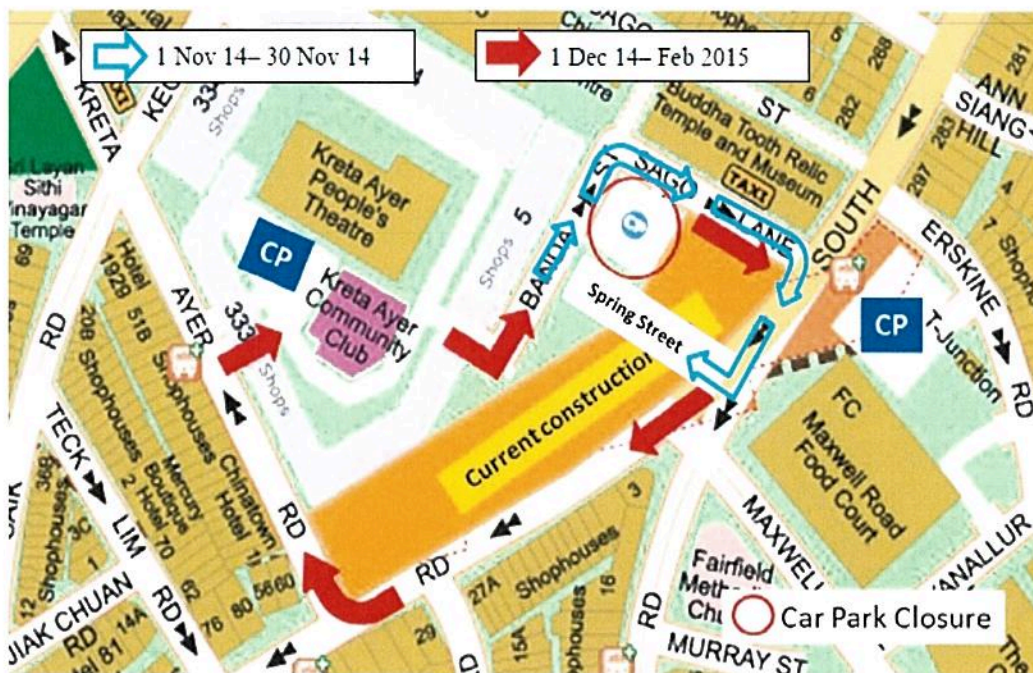

TEMPORARY CLOSURE OF SPRING STREET CARPARK (OFF-STREET) FROM 1 NOVEMBER 2014 AND SPRING STREET FROM 1 DECEMBER 2014

Thank you for your support and understanding towards the construction of the Thomson-East Coast Line (TEL) Maxwell station.

2 We would like to inform you that the URA carpark along Spring Street, i.e. Spring Street Carpark (off street) will be temporarily closed for reconfiguration works from 1 November 2014 to February 2015. Spring Street will be accessible until the end of November 2014. Thereafter, it will be closed from 1 December 2014 and will be reinstated by 4th Q 2018.

3 Please note that Banda Street and Sago Lane are still accessible by car throughout the carpark closure. Kindly see the enclosed layout for directional access to Banda Street and Sago Lane:



4 During this interim, motorists may consider to park at the carpark/ car lots along Duxton Road, Duxton Hill Rd, South Bridge Road, Blk 333 Kreta Ayer Road, URA East Wing etc. For coach drivers using the Spring Street designated coach lots, we have temporary coach lots allocated along Mosque Street and Peck Seah Street. We encourage all motorists to plan their journey to the vicinity beforehand to avoid confusion driving around the area.

5 Rest assured that we will work closely with our main contractor to implement appropriate mitigating measures to minimize the inconveniences and ensure the safety of the motorists and pedestrians in the area.

2. 因为施工的要求，市建局史必灵路停车场将在 2014 年 11 月 1 日到 2015 年 2 月局部关闭。史必灵路将从 2014 年 12 月 1 日暂时停止使用，将于 2018 年第四季重新建回。

3. 需要经由万达街和硕莪巷的机动车辆驾驶者请参阅下面的路线图。

4. 在此期间，机动车辆驾驶者请考虑使用达士敦路，达士敦山巷，大牌 333 以及市建局东翼等附近的停车场。至于史必灵旅行巴士停车位使用者，我们已经安排临时旅行巴士停车位位于摩士街与柏城街。为了您的方便，我们建议来往此地的机动车辆驾驶者事先做好线路的研究和计划。

5. 施工期间，难免会产生一些如噪音，灰尘，交通改道等等的不便，我们将和我们的总承包商紧密携手合作，推出种种适当的措施，尽量将不便减到最低，并确保驾车人士和行人的安全。
